1. The quotation should be sent by mentioning the vehicle No. **OR 07 A 1084** on the closed envelop containing the EMD.
2. The tenderers with highest quotation shall be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and rest auction amount shall be deposited within seven days or at the time of taking delivery of the vehicle, whichever is earlier.
3. The EMD of all successful tenderers will be refunded to them on the same day.

4. If the price offered by sealed tenders are found less than the upset price, then competent authority may opt for fresh auction sale.
5. In case the successful tenderer fails to deposit 75% of balance auction price at the time of taking of delivery of vehicle within 7 days, his tender paper will be cancelled and the EMD along with 25% deposit will be forfeited.
6. The highest bidder will remove the vehicle within 3 days of deposit of the total amount, failing which ground rent of ₹. 100/- per day will be charged till final removal of vehicle.
7. Where the ground rent so charged exceeds the price deposited by the tenderer, shall cease to have any right on the vehicle and amount deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction / tender as the case may be.
